- D. Computer hardware and software utilized in the business or in a personal capacity and to search files on the hard drive, removable hard drive or other removable storage media, jump drives, thumb drives, or any other information storage device.
- E. Sales ledgers, general ledgers, profit and loss statements, balance sheet statements, federal tax returns to include any tax returns filed by or on behalf of Virginia Garwood, Kristen Garwood Breezy Valley Dairy Farm, Breezy Dairy Farm, or Breezy Farm and any business in which Virginia Garwood, Kristen Garwood, Breezy Valley Dairy Farm, Breezy Dairy Farm, or Breezy Farm is an officer, shareholder, partner, sole proprietor, or active or passive participant.
- F. Any and all payroll tax returns to include but not be limited to Federal Forms 941, W-2, Wh-3, Wh-1, UC-1, UC-5 and 940, as well as State and local income tax returns, sales and use tax vouchers, worksheets used in the preparation of any tax return, payroll withholding tax returns and sales and use tax vouchers for any and all businesses of which Virginia Garwood, Kristen Garwood, Breezy Valley Dairy Farm, Breezy Dairy Farm, or Breezy Farm is an officer, shareholder, partner, sole proprietor, or active or passive participant.
- G. Any business and personal financial records which may be located, including but not limited to: communications, correspondence, letters, memoranda, contracts, agreements, notes, charts, tables, spreadsheets, reports, compendia, compilations, books, monographs, abstracts, summaries, diaries, calendars, planners, schedules, digests, ledgers, logs, lists, and all other recordings of information, images or sounds on paper, of any kind or description whatsoever, including drafts of any such item, and all information-storage media, including but not limited to computer disks, compact disks, magnetic tapes, magnetic cards, hard disks, floppy disks, CD-ROM disks, phonograph records, cassette tapes, reel-to-reel tapes, and all other forms of recorded or memorialized data, symbols, notations, words, information, images or sounds.
